If for whatever reason, the Landlord decides not to proceed with the tenancy, the first month's rent or any funds paid to Premier Student Property by you will be refunded in full. In the event that you do not proceed with this tenancy, or do not provide the required documentation as per the application checklist and / or sign the tenancy agreement, within 10 working days of the application date, the property will be re-advertised, and the first month's rent will be non-returnable in part or whole, even if a tenancy agreement has not been signed.

On or before the commencement date of the tenancy, the deposit must be paid to the Landlord or the Landlord's Agent. Occupation of the property will NOT be granted and NO keys will be given out until the full deposit is paid. The deposit cannot, under any circumstance, be used to cover the last month's rent.
